



HOW BILLS BECOME LAWS IN ILLINOIS


State Legislative Advocacy

We can work to influence LAWS by influencing PEOPLE.

- Legislators are people elected to make laws.
- There are **177** legislators in illinois.
- Each legislator represents a district.
- There are **59** Senate districts and **118** House districts:
 - Two House districts are contained in every Senate district.
 - Every home address is linked to one state representative and one state senator.



Who Makes the Laws





59 State Senators

118 State Representatives

Lawmaker Demographics

State Senate: 59

MAJORITY DEM, MALE, WHITE

- 40 Dems, 19 Repubs
- 68% white, 20% Black, 10% Latinx, 2% A/PI
- 58% men, 42% women

Senate President: Don Harmon

State House: 118

MAJORITY DEM, MALE, WHITE

- 78 Dems, 40 Repubs
- 64% white, 19% Black, 10% Latinx, 7% A/PI
- 59% men, 41% women




2020 PRESIDENTIAL ELECTION RESULTS

SCENARIO: The Ice Cream Bill

Your community organization believes all Illinois children should get ice cream on their fifth birthday, subsidized by the state general revenue. Ice cream manufacturers love the idea. Other parent groups in your area are pleased because COVID-19 has been hard on them, their kids, and the ice cream industry, and they feel like we could all use a little ice cream. Your local State Representative agrees to file a bill.



SCENARIO: The Plot Thickens...

The bill is assigned to committee. Your sponsor calls you 5 days before the committee hearing to give you an update.

The cake lobby, which is most active in Southern Illinois, asked you to drop the bill. The Illinois Dental Health Association has also expressed concerns. She tells you the bill may not make it through committee, and neither the Democratic nor the Republican caucus will take a positive position on it, leaving legislators to vote their conscience.

She did not realize it would be so hard. She seems on the fence about how to proceed, and asks you what your group thinks the next step should be...



SCENARIO: A Crossroads...

Do more hard work (lobby more people, in more places, in different ways) Negotiate with opponents to make the bill more palatable to them







What You Can Do For Your Team

- What can you learn from **your** 1 of 118 and 1 of 59?

- What do they post on **social media**?
